
1. That the Hazaribag, Jesuit education society section 8 is a registered Society/Trust under the act XXI of 1860.

2. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.



13. That the school will ensure that the school fulfills all essential requirements before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation bye-laws or notified from time to time.



